Annual Water Quality Report for the period of January I to December 31, 2020.

This report is intended to provide you with important information about your drinking water and the efforts made by the water system to provide safe drinking water.

The City of College Park drinking water is provided by City of East Point Water System (55%), Clayton County Water Authority (38%) and Groundwater facilities (7%).

Over the next few years, the City of College Park will invest in capital improvements to upgrade our water system to replace aging facilities, equipment, and water lines to improve reliability and operational efficiency.

Why this Report?

The Safe Drinking Water Act requires public water systems to provide annual water quality reports to all water customers. The City of College Park supports this effort.



Sources of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPAs Safe Drinking Water Hotline at (800) 426-4791.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturallyoccurring or be the result of oil and gas production and mining activities.

- Avg: Regulatory compliance with some MCLs are based on running annual average of monthly samples

 Action Level Goal (ALG): The level of a contaminant in drinking water
- below which there is no known or expected risk to health. ALGs allow for
- Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Containment Level Goal or MCLG: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Level I Assessment: A Level I assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
- Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Level 2 Assessment: A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

- Maximum residual disinfectant level or MRDL: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control
- Maximum residual disinfectant level goal or MRDLG: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- N/A: not applicable mrem: millirems per year (a measure of radiation absorbed by the body) ppb: micrograms per liter or parts per billion or one ounce in 7,350,000
- gallons of water
- ppm: milligrams per liter or parts per million or one ounce in 7,350 gallons
