AVAILABILITY:

Service is available throughout the limits of the City of College Park in accordance with the City’s Applicable Ordinances, Rules & Regulations

APPLICABILITY:

Residential services are applicable to all indoor and outdoor domestic uses of the customer.

TYPE OF SERVICE:

Service under this schedule includes the provision of treated water, through either an individual meter at a single family home or a master meter at a multi-family apartment or condominium complex.

MONTHLY WATER CHARGES:

The total monthly residential water charge shall be the sum of the Water Supply Charge plus the Water Delivery Charge.

SUPPLY CHARGE – ALL CUSTOMERS ⁽¹⁾

For all KGAL ⁽²⁾ @ \$4.18 per KGAL

DELIVERY CHARGE – SINGLE FAMILY RESIDENCES ⁽³⁾

Basic Facilities Charge @ \$10.76
Tier 1 – For the first 4 KGAL..... @ \$1.08 per KGAL
Tier 2 – For the next 4 KGAL @ \$1.62 per KGAL
Tier 3 – For greater than 8 KGAL..... @ \$2.15 per KGAL

DELIVERY CHARGE – MULTIFAMILY RESIDENCES ⁽⁴⁾

Basic Facilities Charge @ \$26.91
Tier 1 – For the first 3 KGAL per Unit @ \$1.08 per KGAL
Tier 2 – For the next 3 KGAL per Unit..... @ \$1.62 per KGAL
Tier 3 – For greater than 6 KGAL per Unit @ \$2.15 per KGAL

MINIMUM MONTHLY CHARGE:

Shall be the applicable Basic Facilities Charge.

DEFINITIONS:

- (1) College Park procures its entire water supply at the best available prices from other governmental agencies.
- (2) Each KGAL shown under the Monthly Water Charges is equivalent to 1,000 gallons of metered water.
- (3) Single family residences include both owner-occupied and rented detached homes. Small multi-unit residences such as duplexes and quadraplexes which are master metered will be billed as single family accounts.

Residents with irrigation meters will pay the supply charge, the basic facilities charge, and the Tier 3 delivery charge for all flow requirements.

- (4) Multifamily residences are defined herein to include five (5) or more dwelling units served by a master water meter. The total monthly water consumption will be divided by the total number of dwelling units in the complex (regardless of current occupancy) to determine the Delivery Charge blocking.

Apartment or condominium complexes with irrigation meters will pay the supply charge, the basic facilities charge, and the Tier 3 delivery charge for all flow requirements.

PENALTIES:

Water/Sewer utility payments are due and payable upon receipt. Payments which are not made by the date printed on the bill are subject to late payment penalties and disconnection of service.
