To the Mayor, Council and citizens of College Park:

I believe that the week of October 26, 2024, may be later viewed as one having some historic significance, and the catalyst for that moment may have been a spark lit in the City of College Park by our former First Lady Michelle Obama.

The former First Lady keynoted the "*When We All Vote*" Rally at the Gateway Center Arena. This organization, founded by Ms. Obama, is nonpartisan and national in scope. The group's purpose is to increase voter turnout among younger adults, and was held on Tuesday, October 29, 2024, one week ahead of Election Day on Tuesday, November 5, 2024. In addition to remarks from Mrs. Obama, the packed house audience hear from actress Kerry Washington, Ari Lennox and Ciara, who also spoke or performed during the event.

Georgia has been setting records with early voting turnout during 2024, as it did with Absentee Ballot voting in 2020, but rural parts of the state were far exceeding the metro Atlanta core counties in terms of percentage of votes cast. As of end of day on Thursday, the early/absentee vote count is nearly 3.8 million, with a voter turnout of 52% of registered voters.

In the two days following that rally, **153,000 more voters** turned up and then turned out in four metro area core counties, pulling their early vote numbers ABOVE 2020 -

Fulton - Up 44,000 ballots

Gwinnett - Up 40, 000 ballots

Cobb - Up 38,000 ballots

Gwinnett - Up 31,000 ballots

As you watch the Election Results roll in Tuesday night and recall that the margin of victory in Georgia during 2020 was just under **13,000 votes**, remember the spark that was lit here in College Park. Congratulations to Yanous Barner and his team at the GICC and Gateway Arena on a well-run show as well as being selected for that momentous event.

Halloween Means Fun & Annual College Park Trunk or Treat Festival -

Our community Halloween celebration was held at the **Tracey Wyatt Recreation Center.** Hundreds of children, their families and city employees enjoyed the evening on October 25th. Thanks to all the city departments, our public safety agencies and local businesses for their contributions of candy and treats, staffing Kiddies Korner and keeping the event and surrounding area safe. We estimate attendance at more than 1,000 at this great annual event.

The Holidays Season will soon be here -

Holiday decorations of Main Street and the Historic District are going up and we will officially kick off the season on Thursday, November 21, with our Annual Senior Thanksgiving Luncheon at the **Tracey Wyatt Recreation Center.** This free event is open to all College Park seniors, ages 55 and up. The holiday feast and gala are sponsored by the City of College Park and the Fulton County Arts & Culture Department.

Tuesday, November 5, 2024, will be Election Day, and we will select our next President, state legislators and numerous local officials here in Fulton County. College Park has been a site for Advance Voting and the Fulton County Elections & Tabulation Center is nearby in the City of South Fulton. Please make a plan and remember to vote if you have not already done so. Building our nation as well as our state and city begins with choosing our leaders.

Code Enforcement Division



The Code Enforcement Division is currently down to one supervisor and three full-time officers. Sooner than later, we will be down to one supervisor and two full-time officers. Recruitment is underway to fill two positions. The division is a powerful tool that will help the city deal with vacant, abandoned, and deteriorated properties and can be used to address health and safety concerns of problem properties and stabilize neighborhoods experiencing decline.

"Many in our profession never hear children say, 'When I grow up, I want to be a code enforcement officer!' Most of the population is unaware that this important profession exists. Code enforcement is a vital tool for communities that makes sure neighborhoods are properly maintained and residents have a safe place to live."

Code Enforcement Officers Are Critical to Community Vitality

Code enforcement officers are vital to maintaining your community's safety, health and overall quality of life. That's a tall ask! These officers are faced with various situations each day that require them to have technical knowledge while also possessing skills in communicating diplomatically and professionally with code violators and complainants.

Code enforcement officers are quasi law enforcement personnel who work for local or county government departments. We enforce their jurisdictions established code requirements, ordinances, and zoning laws, as well as any adopted codes such as state codes or model codes.

Code enforcement officers frequently receive complaints from citizens, other city departments and outside agencies. We investigate those complaints and if they confirm violations, then we will work with property owners to ensure that they comply with local regulations. Voluntary compliance is always the main goal for a code enforcement officer. An effective officer uses their words and emotional intelligence to achieve this goal.

Planning and Growth Management

Planning Commission

The October 28th Planning Commission meeting was held with all members in attendance. Items on the Planning Commission Agenda included a public hearing to consider a Conditional Use Permit for a vape shop at 4843 Old National Highway in the International Plaza commercial center. A motion was passed to recommend approval of the CUP subject to conditions set forth by the City Planner, and further review and recommendations from the Public Safety Division prior to issuance of a business license and Certificate of Occupancy. The Planning Commission also approved a motion to bring to City Council a request to initiate a moratorium on Vape Shop applications in order for us to analyze and establish distance standards from similar businesses and sensitive uses.

The Planning Commission also considered text amendments to the Zoning Code to require a Conditional Use Permit for extended stay hotels and limit their locations to the Hospitality Campus (HC) and Community Business (C2) Districts. This item was tabled to the next meeting in order for the Commission to further propose modifications to the Zoning Code sections addressing extended stay and traditional hotels to consolidate the conditions to make it more user friendly and establish reporting and monitoring requirements.

The 2025 meeting schedule was discussed. As the remaining 2024 dates fall within a few days of legal holidays, the PC has determined they will hold a special call meeting the first or second week of December to wrap up the zoning code text amendment recommendations to Council. Legal notices for that special call meeting date, TBD by 11/6, will be posted on 11/14.-----This

Board of Zoning Appeals

There are two (2) variance applications to be considered at the upcoming November 11th meeting. The legal notice has been publicized and packages will be distributed digitally on 11/6.

Pre-Application Meetings, Use and Development Inquiries, Code Enforcement Support, Plat Maps, Business License Review, Zoning Confirmation Letters

- The City Planner continues to coordinate with the Building Department and City Engineer to respond to inquiries and permit applications regarding potential use of land, site development, zoning verification letters, auto broker licenses, business licenses, stream buffer variance, potential rezoning, sign permits, plat map subdivision or consolidation, and preliminary review of renovations/additions. City Planner reviewed 28 various permit applications in October 2024.
- Continued support, research and information provision to Code Enforcement.
 Work with City Attorney in preparation for and attendance at, Court session re:
 Rogers Automotive at 2525 Riverdale Rd. This item is being continued in November.

• The City Planner has been requested by the Public Safety Department to establish a School Safety Zone around 3 educational facilities. Research is underway and the CP is coordinating with the Fulton County School District and the State to officially demarcate the boundaries.

• The City Planner continues to evaluate the Zoning Code and is preparing a list of modifications to the code to introduce to the City Attorney for inclusion in their zoning code overhaul.

Hotel and Vacation Rental Fire Safety

Fire safety is just as important when people are away from home. While there are fire safety regulations in place for hotels and motels, homes and apartments used for vacation or short-term rentals are not regulated to the same extent.

Fire safety is important, even when you are away from home.

Stay in <u>hotels and motels</u> that have hard-wired smoke alarms and an automatic fire sprinkler system in each guest room.

- Read the evacuation plan carefully.
- Find the 2 closest exits from your room.
- Count the number of doors between your room and the exits. This will help if you need to get out in the dark.
- Find the fire alarms on your floor.



Physical Agility Test




October 19th Keep College Park Beautiful took part in Georgia's River Alive program whose mission is to create awareness of and involvement in the preservation of Georgia's water resources. Rivers Alive served to combine all the various cleanups across the state into a single, unified cleanup program. The formation of Rivers Alive made it easier for cleanup organizers to receive supplies and materials, funded by corporate donations, as well as consolidate the cleanup data across the state. The program also partnered with the International Coastal Cleanup, a program of the Ocean Conservancy, to stretch its efforts to the coast.

Rivers Alive has seen tremendous growth since its founding over 20 years ago. Its success stems from both the event organizers and the Rivers Alive Advisory Board who dedicates countless hours fundraising, creating educational materials, and planning community outreach efforts. The program's continued success is also dependent on a strong volunteer base that is concerned about and prepared to take action to protect their local waterways. Everyone who participates in Rivers Alive, in whatever capacity, is working to help keep our watersheds clean and healthy.

In River's Alive latest report (2022), 132 cleanup events and 5,143 bags of trash were collected throughout the year from our waterways, cleaning 623 miles. A workforce of 11,432 volunteers, working 36,968 cleanup hours, generated 401,285 lbs. of trash from going downstream to our neighbors.

Keep College Park Beautiful will be among the numbers for 2024 as we have done 2 creek cleanups this year, March 25th and October 19th, in our city and collected 30 bags of trash and other miscellaneous items. A workforce this year of 15 volunteers, working 45 hours, generating 450 plus pounds of trash from about ½ mile of Camp Creek. Next year we hope to double our numbers in all areas. We hope you will join us.


Basketball Court Ribbon Cutting and Dedication -This and ANTHONY
